- Dead tree on inbound side of boulevard just before Meadows on right needs removed.

#### **Other Old Business:**

- The Board previously committed to buying and approved \$300 for the purchase of new playground swings. Matt Corsello has taken ownership of this and will secure the new equipment.
- We are still lacking the correct admin password in order to add additional users to the pool/common area camera/security system.
- Several residents continue to ask the Board for a directive on metal roofs.
