

Brandymill HOA Board Meeting Monday, June 17th, 2019 Summerville Hospital Cafeteria 7:00PM ET – 7:57PM ET

In attendance were Jeri Craig (Treas), Matt Corsello (Sec), Craig Hansen (Member-at-Large), 2 committee chairs and 3 community members (see attached).

Secretary Matthew Corsello called the meeting to order at 7:00PM. Secretary Matthew Corsello recalled old business from the previous months' meeting minutes.

ARC:

- Nothing to report

Welcome Committee:

- Janice McClister (chair) has magnets and has begun to reconcile missed welcomes

Pool Committee:

- Community trash receptacle stolen from park/playground area; Evie will file police report and coordinate replacement
- Vending machine [still] needs serviced
- [More] wasp/hornet spray needed for pool area
- Some soffit and facia boards need cleaned/repaired
- Evie asked that residents pass through common area/pool on way in/out of neighborhood in order to deter loitering and call the police if you see suspicious activity
- Deposit of \$3,795, 72 total memberships purchased so far this year
