I. REVIEW of MINUTES

Andy White reviewed issues from the last meeting (addressed further in other sections).

II. COMMITTEE REPORTS

A. Welcome Committee

In absence of the Committee Chair, Rose Ragole mentioned follow-up was completed on four of five homes. Three unsuccessful attempts have been made to reach the fifth home. Rose and Andy will continue attempts to make contact.

B. Architectural Review Committee [ARC]

Andy White reported fencing completed on the Boulevard. Positive comments of members

were expressed. Merrill Ridgeway related there was one request for repainting in an otherwise 'quiet' month.

C. HOA Phone Line

Andy White reported calls regarding a 'visible' boat and shed (not acceptable per Covenants & Restrictions). Continued infractions (after notification) result in daily fines and, eventually, liens.

Mary Stellrach is doing a good job as Phone Coordinator. Thanks Mary!

D. Pool/Recreation

Andy White and Merrill Ridgeway discussed problems with a toilet that may need to be replaced. Also, a Pool fill valve [gooseneck] broke and will need repair.

E. Christmas Lights/Yard of the Month

Regarding Christmas Lights, three homes were selected for most traditional, most lights and most childlike. Lowe's \$25.00 Gift cards are to be awarded. Winners will be reported next month

when Committee Chair is present. Yard-of-the-Month selections are made each month for five months (in April through August).

Andy reminded members that when a Holiday occurs during the week, that can cause a service delay to the next day (generally). Additionally, now that the Holidays are over, members should insure compliance with *Covenants & Restrictions*. There should be no parking in the streets. Trash cans should not be visible from the street. HOA members are asked to please make 'kind' attempts to 'remind' neighbors of any

noticed infractions relating to Covenants & Restrictions.

H. Beautification

Rose Ragole noted that Pine Straw had been placed on the Boulevard and side entrance areas needed, as approved by the Board. Owens Landscaping was able to complete the additional

work prior to Christmas and the Boulevard looked great! Rose reported that the Beautification Committee did not meet the past month. Rose submitted a written report.
