Meeting was called to order at 7:05 PM ET

Pool Committee:

- Pool Committee Chairperson was present
- 94 residents bought pool passes in 2021
 - Including pool parties and member fees, the pool generated \$12,500
- A new access control system will be installed in the coming year
- Pool deck needs rehab
- A new pool service contractor is being considered
 - The current pool contractor charges:
 - \$1000/month when the pool is open
 - \$600/month when the pool is closed
- All residents should take some ownership of the condition of the pool
 - This means:
 - Picking up after yourself
 - Not vandalizing the pool in any way
 - Treating the pool as if it were your own

- Account balance w/ reserves: \$205,902.80
- Outstanding dues: \$48,151.93

Community Standards:

New Business/Open Floor:

- A resident complained that people leave boats, trashcans, garbage in front of their houses. As well as having broken/non-existent garage doors, and livestock.
 - It was reiterated that the HOA can only issue fines regarding many violations
 - Town of Summerville Department of Code Enforcement (843-695-6511) is another resource to resolve these issues
- It was proposed that the HOA terminate our current landscaping contract and use another contractor due to quality of work
- It was proposed that signs, trees, and bushes need to be replaced along the Blvd.
 - To include the sign that displays when HOA meetings will be
 - To also include adding a new sign that displays the HOA phone number and HOA website
- The underground water meter near the entrance to the Blvd. is open and is a trip/fall hazard
 - This needs to be resolved immediately
 - Could present future legal issues for the HOA
- People are dumping garbage by the pool
 - Trash/garbage → bad
 - Old wood from replaced fences stacked neatly \rightarrow ok
